

India's nominal GDP may hit a six year low: Corporate revenue growth to lag in FY26 Report

India's corporate revenue and earnings momentum may face headwinds in the upcoming financial year due to an expected moderation in nominal GDP growth, according to a report by Jefferies.



Monsoon revival in Maharashtra

After a brief pause, heavy monsoon rains swept across Maharashtra starting 13th June, Friday, with Mumbai also experiencing a resurgence of monsoon showers. Mumbai's Santacruz observatory logged 19 mm rainfall between 14th June, Saturday and 15th June, Sunday morning,

while the Colaba coastal observatory recorded 34 mm rainfall.



India's GST collection rises 6.2% YoY to Rs 1.85 lakh cr in June

India's gross Goods and Services Tax (GST) collection for the month of June stood at Rs 1.85 lakh crore, marking a 6.2% increase compared to the same month last year, government data showed Tuesday. However, month-on-month, GST collection in June dipped as April 2025 saw a record Rs 2.37 lakh crore

collected, followed by Rs 2.01 lakh crore in May.

Skilled Migration to Germany: The Crucial Role of Language in Integration and Career Advancement

Hey there! I am Ishita Makhija, an intern at Hamburg Representation Mumbai. In today's From the Interns Desk I would like to share about how the German language to live in Germany may not be necessary, but it surely increase odds in career advancements and makes the transition smoother.

Germany stands at a pivotal crossroads as it grapples with profound demographic challenges—most notably, an aging population and persistently low birth rates. These shifts have triggered an urgent demand for skilled professionals across sectors such as engineering, information technology, healthcare, and skilled trades. In response, the German government has enacted progressive immigration reforms aimed at attracting and integrating foreign talent into its labour market and society.

Germany's commitment to addressing its labour shortage is most clearly reflected in the Skilled Immigration Act (Fachkräfteeinwanderungsgesetz – FEG), initially introduced in March 2020 and significantly upgraded in June 2023. These reforms, implemented in phases between November 2023 and June 2024, streamline pathways for skilled workers from non-EU countries.

Key updates include:

Relaxed requirements for vocational professionals, such as reduced German language proficiency and simplified recognition of qualifications for unregulated professions.

Broader employment access, allowing skilled workers to take any qualified job, even outside their formally trained professions, provided they meet a salary threshold.

Vocational pathway: Foreign nationals with two years of vocational training and two years of work experience within the last five years can work in skilled roles without a German-recognized degree.

The EU Blue Card scheme has also become more inclusive. Salary thresholds have been lowered substantially—down to approximately €43,800 for regular professions and €39,682 for shortage occupations in 2024. IT specialists can now qualify even without a university degree if they possess three years of professional experience. Blue Card holders can also secure permanent residency faster—within 21 months (with B2 German skills) or 33 months (without language requirements).







Launched in June 2024, the Opportunity Card offers a one-year renewable residence permit for job seekers. Using a points-based system, it evaluates applicants based on qualifications, work experience, language skills (German and English), age, and ties to Germany. This card allows trial employment for up to two weeks and offers a pathway to permanent residency within 18 months—provided applicants acquire German language skills and secure employment.

While entry into the German labour market has become easier, the ability to speak German remains indispensable for sustainable career growth. Only around 2.7% of job listings explicitly state that "German is not required," while approximately 97% require some level of German proficiency. Even in international companies and IT roles in major cities like Berlin, Frankfurt, or Munich, German often functions as the default language—especially when colleagues from various non-English-speaking backgrounds are involved.

For sectors such as healthcare, finance, law, and public administration, German proficiency is non-negotiable. Even in IT, roughly 95% of roles operate in German, particularly among the small and medium-sized enterprises (Mittelstand) that form the backbone of Germany's economy. Applicants with only basic German (A1 or A2 CEFR level) often face rejection due to communication limitations. Interestingly, job listings in German attract far fewer applicants—an average of 50 versus up to 5,000 for equivalent roles advertised in English. Mastering the language not only increases access to higher-paying jobs but also dramatically reduces competition.


Beyond professional settings, German language proficiency is essential for social integration. It enables newcomers to navigate daily tasks, communicate with public authorities, participate in community events, and build authentic relationships. Without these skills, immigrants may remain isolated in ethnic enclaves, limiting their social and economic potential. However, integration is a two-way street. While the onus is on immigrants to learn the language, societal openness is equally crucial. Rejection—whether overt or subtle—can deter even motivated learners from integrating. Thus, while language is a key bridge, true inclusion depends on mutual effort and acceptance.

Recognizing the importance of language, Germany has adopted a "language skills first" strategy. This is implemented through Integration Courses, funded by the Federal Office for Migration and Refugees (BAMF). These include:

600 hours of language instruction and 100 hours of orientation on German culture, laws, and daily life.









Specialized tracks for women, young adults, parents, and individuals with literacy challenges.

B1 CEFR proficiency goal, essential for permanent residency and long-term employment.

Final exams: the German Test for Immigrants (DTZ) and the Life in Germany (LiD) test.

Courses are partially subsidized (e.g., EUR 2.29 per lesson), with possible fee exemptions and partial refunds upon successful completion. Fast learners can opt for intensive courses with condensed content.

Germany's evolving immigration policies underscore its urgency to fill labour gaps—but language remains the gateway to long-term integration and success. While initial entry requirements have been relaxed to attract talent quickly, thriving within German society demands fluency.

Proficiency in German not only opens up many employment opportunities but also fosters genuine social inclusion, cultural understanding, and a sense of belonging. The German language plays an important role as it continues to be the main language of the country. The Government is lending a helping hand with the foreigner who are coming to Germany as they are providing courses to integrate Internationals in the country. As Germany continues to welcome skilled migrants, those who invest in language learning will find themselves best positioned to build fulfilling and sustainable lives in the country.
